MEMO

DATE: MARCH 4, 2022

KSTD received a significant and generous charitable donation from Fairfield Trustee Albert E. Hodsdon III in the amount of \$32,000.00 on February 22, 2022. Mr. Hodsdon stated that he wanted the money to be distributed to the District Member Communities affected by the 2019 force main failure and subsequent expenditures that resulted in the repair, replacement and miscellaneous fees associated with the incident. KSTD would act as a pass-through entity to distribute the funds.

I am recommending that the Board first take action to accept the charitable donation from Mr. Hodsdon in the amount of \$32,000.00. Further, I am recommending that the Board take separate action to accept the following distribution of the funds based on 2019 flow data at Main Pump Station in Waterville. Mr. Hodsdon's intentions were clear that the money would be dispersed to member communities affected, that being the Town of Fairfield, Town of Benton & the Waterville Sewerage District. While Huhtamaki, Inc. contributes a significant amount of flow to Main Pump Station, they are not a District Member. Upon acceptance, the District will distribute checks directly to member communities in the totals on the last column of Table 1. See below:

The Town of Winslow operates its own station and pumps directly to facility.

Savage St and H Meter Pit serve only the Fown of Fairfield.
