

Special Town Meeting Warrant January 17, 2024

To: _____, a resident of the Town of Benton, in the County of Kennebec and the State of Maine.

Greetings: In the name of the State of Maine you are required to notify and warn the voters of said Town of Benton, in said County, qualified by law to vote in town affairs, to meet at the Benton Town Office in said Town on Wednesday, the 17th day of January, A.D. 2024 at 6:00 p.m. local time to elect a Moderator to preside at said meeting, and to act on the following articles, to wit.

Inclement weather date and time is set for Friday, the 19th day of January, A.D. 2024 at 6:00 p.m. local time, meeting at the Benton Town Office in said Town. The Town will provide notice on the Town of Benton website, Benton, ME | (bentonmaine.info) should we need to move the January 17, 2024 date to this alternate time.

Article 1	To elect a Moderator to preside at said meeting
Article 2	Shall a moratorium entitled "High-Impact Electric Transmission Line Moratorium Ordinance Town of Benton" be enacted? Select Board Recommend: Yes (3)
Article 3	Shall an Ordinance entitled "Ordinance to Regulate Automobile Graveyards, Junkyard and Automobile Recycling Business, Town of Benton, Maine" be enacted? Select Board Recommend: Yes (3)
Article 4	Shall an ordinance entitled "Public & Private Sewer Ordinance Town of Benton, Maine" dated March 26, 2022, be modified to allow a standard credit be applied to the rate payer's sewer account not to exceed \$10.40 for use of substantial amount of water that will not be entering the sewer system? Current Language: (Article XIII, Sewer Service Charge, Section 8) Section 8 In the event that a rate payer will be using a substantial amount of water that will not be entering the sewer system, an external flow meter may be rented from the Town, under certain terms and conditions, so that a credit towards consumption amounts may be calculated. Example: pool fill-up. <u>A standard credit will be applied to the rate payer's account. The amount not to exceed \$10.40. The amount may be changed at the discretion of the Select Board</u>




